RE: Water Main Relocations Required by City of Sherwood's Road Improvement Project
Country Club Road between North Hills Blvd. and Beaconsfield Road

Dear Resident:

In preparation of the City of Sherwood's future project to construct road improvements along Country Club Road between North Hills Blvd. and Beaconsfield Rd., Central Arkansas Water (CAW) has contracted with NLS Construction (Rose Bud, Arkansas) to relocate water mains that are currently in conflict with the future road improvement work.

For the water main relocation work you can expect digging and trenching in the road surface and grassy area in front of your property. Traffic control will be coordinated with City of Sherwood. The service line from the new water main to your water meter will also be replaced. If your water meter is not currently near the road right-of-way line the new replacement water meter will be installed near the road right-of-way line. We will need to temporarily interrupt water service when water meters are transferred to the new main. We will provide you advance notice prior to this interruption of service. The service line from the meter to the houses will not be replaced.

The water main relocation work will start about April 12th and will be constructed in two phases. Phase one will be completion of the west half of Country Club Road between North Hills Blvd. and Beverly Avenue. Upon completion of the phase one work, the phase two work will start along the east half of Country Club Road between Beverly Avenue and Beaconsfield Road.

The entire water main relocation project will take approximately five months to complete. Unfortunately, all times are estimated and subject to change due to weather or unforeseen conditions that we may encounter once excavation begins.

After installation, the new main will be flushed and tested. During this time, you will notice water being discharged into the gutter at various locations along Country Club Road. The flushing and testing phase will take several days to complete. Although it may appear this water is being wasted, this water discharge is required to place the new water main in service, ensuring that the water in the pipes is clean and safe.

Before and after construction, CAW may test the pressure and flow of your water service line using an outside faucet on your property. This data will help CAW monitor and address any issues resulting from the work.

If you have any questions or issues concerning this work, please call me or talk to the contractor's supervisor or foreman on-site during construction.
